Under the terms of the Collective Bargaining Agreement between the Steel and Iron Contractors Association and Iron Workers' Local No. 17, Cleveland, Ohio, a wage increase of two dollars per hour (\$2.00) was provided to be effective May 1, 2024 into the wage & fringe benefit package. The distribution of this \$2.00 is as follows: \$0.70 into the Annuity Fund; \$0.25 into the Insurance Fund; \$0.05 into the Apprenticeship fund; \$1.00 into the Hourly Rate.

Please note, if you add the vacation pay to members gross wages to be taxed you must also deduct it back out. Questions on this calculation please call the union offices prior to your payroll.

*WORKING ASSESSMENT: A Union working assessment check-off of four and one-half percent (4.5%) of the <u>HOURLY RATE</u>, paid to each employee covered by this Agreement shall be maintained through a payroll deduction from the employee's <u>HOURLY RATE</u>, and shall be reported on the Fringe Benefit forms along with \$28.46 per hour in taxable and non-taxable fringes. <u>PLEASE NOTE: The Vacation Fringe is excluded from the taxable hourly rate when calculating the working assessment.</u>
