## **Civil Rights Transportation Symposium Scholarship 2019-2020 Academic School Year**

In celebration of the 3rd Annual Civil Rights Transportation Symposium, (3) Three \$1,000 scholarships will be awarded to (3) individual students currently enrolled in a post high school education focusing in STEM (Science, Technology, Engineering or Mathematics) related fields. The Civil Rights Transportation Symposium Scholarship focuses on broadening the number of individuals in the management and operation ranks of the engineering and transportation industry.

#### **Scholarship Eligibility**

To be eligible for this one-time, non-renewable **\$1000** award the applicant must:

- Be enrolled as a full-time undergraduate in an accredited degree-granting institution; and
- Have a minimum GPA of 2.5 ("C+" average); and
- Be pursuing a Science, Technology, Engineering or Mathematics Degree; and
- Demonstrate financial need (verified by college or university); and
- Have authorization to work in the U.S.

#### **Required Documents to Submit**

- Scholarship Application. A completed and signed form is required;
- <u>Verification</u>. Statement from a Bursar/Ombudsman staff person at your college or university confirming financial need, current enrollment; and
- Transcript. Provide information that indicates current GPA;
- Resume. Provide past and current information regarding your work career;
- <u>Essay</u>. Your submission must not exceed a maximum 800-word typed essay, double spaced with an 11-point Arial font in an MS Word document.

Topic: In your own words describe how the Civil Rights Act has impacted the transportation industry to date, and the role you foresee it having in the future.

Completed application and all supporting documents must be received via email no later than 11:59pm on March 1, 2019. Please electronically submit all information to Maria Davila at Maria.Davila@dot.ohio.gov. The Scholarship award winners must be present to accept the award at the 3rd Annual Civil Rights Symposium on April 09, 2019. Winners will be notified prior to event.
